You may refuse to answer any of the questions and you may stop your participation in this study at any time.

The two semi-structured phone interviews will be recorded, and the recordings will be used to generate a written transcript of the interviews. Consent forms and data documents will be stored in a password-protected word processed file to reduce the confidentiality risks to participants.

You will not benefit directly from your participation in the study. The benefits to science and humankind that might result from this study are your experiences as a teacher of students with traumatic brain injury will provide insights on how to better serve students with TBI.

Every effort will be made to keep your information confidential, however, this can not be guaranteed.
